WHEREAS, by Resolution No. 218116 adopted on April 6, 1977, and Resolution No. 219771 adopted on November 30, 1977, the City Council approved the rules and regulations governing the Tecolote Canyon Citizens Advisory Committee; and

WHEREAS, said rules and regulations provide for the holding of a one-time election to elect 12 members of the Advisory Committee from six subdistricts within the Tecolote Canyon Open Space District; and

WHEREAS, the City Council now desires to provide for appointment rather than election of said 12 members; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Bylaws of the Tecolote Canyon Citizens Advisory
Committee are hereby amended to provide as follows:

ARTICLE IV, ADVISORY BOARD, is hereby modified to read as follows:

Section 1. The Advisory Board shall be composed of 21 members. Each City Councilmember and the Mayor shall appoint one member. The nine members so appointed shall elect a chairperson who shall appoint, subject to confirmation by a two-thirds' vote of said nine members, the additional 12 members.

MCROFILIED

Section 2. Board members shall serve for the life of this organization.

ARTICLE V, NOMINATIONS AND ELECTIONS, is hereby deleted in its entirety.

ARTICLE VII, OFFICERS, is hereby modified to read as follows:

Section 1. The initial officers shall be nominated and elected by and from the initial nine members appointed by the City Council. Officers shall thereafter be annually nominated and elected by and from the 21-member board by the majority vote of the total membership.

Section 5 is hereby modified to delete the last sentence thereof which reads as follows:

> The Secretary shall maintain an upto-date list with names and addresses of all registered voters and/or owners of assessed property in the Tecolote Canyon Assessment District.

ARTICLE IX, AMENDMENTS, is hereby modified to read as follows:

Section 1. Amendments to these bylaws may be proposed by a majority vote of the Advisory Board or by a essment District.

Section 2 is hereby deleted in its entirety
