

2. That the City Auditor and Comptroller is hereby authorized to delete CIP 21-002.2, General Lighting, Phase 3, and authorized to transfer \$20,200.00 from this project to CIP No. 21-025.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$11,000.00 from CIP 90-725, Park and Recreation Bond Fund Reserve to CIP No. 21-025.
