BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. General Electric Supply Co, 2. Bar-0-Lite Barricade and 3. Dardanella Electric Corporation are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of DRY CELL BATTERIES as may be required for a period of one (1) year beginning July 1, 1978 through June 30, 1979 per prices on file in the Purchasing Department, as follows:

1. General Electric Supply Co. for Section 1 (Flashlight Batteries); terms 2% 30 days plus sales tax, and with an option to renew for one (1) additional year;

2. Bar-0-Lite Barricade for Section 11 (Lantern and Ignition Batteries); terms 2% 10 days plus sales tax, and with an option to renew for one (1) additional year;

3. Dardanella Electric Corporation for Section 111 (Other Carbon Zinc, Alkaline, and Mercury Batteries); terms 2% 20 days plus sales tax; and with an option to renew for one additional year.
