APPROVING MAP OF LA JOLLA ALTA P.R.D. UNIT NOS. 9 & 10
AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE OF
COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by W. R. NOTHOMB, a Licensed Land Surveyor, entitled "LA JOLLA
ALTA P.R.D. UNIT NOS. 9 & 10 Being a subdivision of portions
of Pueblo Lots 1775 and 1255 of Pueblo Lands of San Diego in
the City of San Diego, County of San Diego, State of California,
according to Map hereof made by James Pascoe in 1870, a copy
of which said map was filed in the office of County Recorder
of San Diego County November 14, 1921, and is known as
Miscellaneous Map No. 36.", is made in the manner and form
prescribed by law and conforms to the surrounding surveys;
that said map and the subdivision of land shown thereon is
hereby approved and accepted; and said Council hereby accepts
on behalf of the public, the following: Via Cabrera, Via
Munera, Via Pravia, Via Pedrera and Via Tabara for public
purposes, and said streets are hereby declared to be public
streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, the easements listed in
paragraphs 1, 2, and 3 of the Owner's certificate, as shown
on this map and subject to the conditions set forth thereon.



BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, LA JOLLA ALTA, a California general partnership, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of LA JOLLA ALTA P.R.D. UNIT NOS. 9 & 10.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
