APPROVING MAP OF REO RANCHO SUBDIVISION JUL 31 1978

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by THOMAS S. W. WONG, a Registered Civil Engineer, entitled "REO RANCHO Being a subdivision of Lot 186 of South Rancho Hills Unit No. 7, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 4512, filed in the office of the County Recorder of San Diego County April 15, 1960.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Reo Place for public purposes; and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the installation and maintenance of sewer and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that


