
Adopted on JUL 31 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Grant deed of VINCENT R. KOZLOWSKI and DOROTHY R. KOZLOWSKI, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of May 22, 1978, conveying to said City a fee interest in Parcel 1 and an easement and right of way in Parcel 2 for earth excavation or embankment, slope or slopes and incidents thereto, over, under, upon, along and across all that portion of the Southwest Quarter of Section 22, Township 18 South, Range 2 West, San Bernardino Base and Meridian, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street, and the same is hereby named PALM AVENUE.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
