
BE IT RESOLVED, by the Council of The City of San Diego as follows:

(Superior Court Case No. 359818), respectively, and of each and every claim against The City of San Diego contained in said lawsuits, its agents and employees, resulting from the arrests of plaintiffs on or about June 11, 1973 and June 10, 1974, respectively.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue warrant/checks in the amounts of \$18,000 made payable to "Levi A. Jefferson and his attorney of record, Jose Otero" and \$7,500 made payable to "Alvin Tolbert and his attorney of record, Alpha Montgomery," in full settlement of the lawsuits and claims mentioned above.
