RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AWARDING CONTRACTS TO THE SAN DIEGO GAS & ELECTRIC COMPANY FOR THE FURNISHING OF ELECTRICAL ENERGY AND SWITCHING TO THE SAN DIEGO STREET LIGHTING MAINTENANCE DISTRICT NO. 1 FOR A ONE-YEAR TIME PERIOD.
