1. That the bid of \$900,561.00 by BRINEGAR & FULLER, INC., a corporation, for the CONSTRUCTION OF FIRE STATION NO. 9 AND FIRE STATION NO. 21, Schedule III and Additive Alternate I in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 763180.
2. Authorizing the expenditure of supplementing FY 79 Capital Outlay Funding in the amount of \$171,463.00 for Fire Station No. 9 CIP 33-048 and \$172,462.00 for Fire Station No. 21 CIP 33-005.
3. That the expenditure of \$500.00 is hereby authorized out of the Community Buildings Bond Fund Reserve of the City of San Diego, solely and exclusively for the purpose of providing funds for said project and related costs.
