Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, a Registered Civil Engineer, entitled "PLAYMOR BERNARDO Being a subdivision of Parcels 3 and 4 of Parcel Map No. 6639, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County, December 9, 1977.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Fairlie Road, Ashburton Road, Timaru Way and Ritidian Way, for public purposes; and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, MICROFILMED the easement with the right of ingress and egress for the

construction and maintenance of drainage facilities, as well as an easement for general utility purposes over, under, upon and across portions of Lots 1 through 11, all as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities and the easement for general utility purposes as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
