That Change Order No. 2, dated June 8, 1978, heretofore filed with the City Clerk of said City as Document No. 764313, issued in connection with the contract between The City of San Diego and Wal-Con Construction, Inc. and John M. Artukovich, a Joint Venture, for CONSTRUCTION OF SEWER MAIN REPLACEMENT GROUP 37 - OCEAN BEACH AREA, said contract having been filed in the office of the City Clerk as Document No. 761958, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of 39,719 be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized and empowered to transfer \$29,306.32, within Sewer Revenue Fund 506, from the Unallocated Reserve, Program Element 69.97 to Program Element 64.92, CIP 44-000.

BE IT FURTHER RESOLVED, that the expenditure of \$39,719 be hereby authorized out of Sewer Revenue Fund 506 of The City of San Diego, solely and exclusively, for the above stated purpose.
