WHEREAS, Harry L. Summers, Inc., is offering a donation of \$7,000 to assist the City in the development of Rolling Hills and Twin Trails Parks; and

WHEREAS, Tree Tops Unlimited and H.G.H. Incorporated is offering a donation of grading valued at \$20,000 at the above two sites; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager of The City of San Diego hereby accepts the generous contribution of \$7,000 from Harry L. Summers, Inc., and directs that said contribution be deposited in Trust Fund 3021 and thereafter be matched by an additional \$7,000 from The City of San Diego to be used exclusively for the purpose of the development of Rolling Hills and Twin Trails Parks.

2. That the City Manager of The City of San Diego hereby accepts the generous contribution of grading valued at \$20,000 at Rolling Hills and Twin Trails Parks from Tree Tops Unlimited and H.G.H. Incorporated.

3. That the expenditure of \$7,000 from the Capital Outlay Fund 245 is hereby authorized solely and exclusively for the City's share of the development of said parks.

4. That the expenditure of \$18,420 from the Capital Outlay Fund 245 Cooperative Park Projects is hereby authorized solely and exclusively for the City's share of the above-described improvement.

5. That this Council does hereby commend Harry L. Summers, Inc., Tree Tops Unlimited and H.G.H. Incorporated for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to these corporations.
