

RESOLUTION NO. 221603Adopted on AUG 8 1978

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Herbert E. Souza	Utilities	\$1,000	Mr. Souza is an Equipment Operator II. Mr. Souza suggested a new method of disposing of sewerage utilizing a blending process. His method reduces the time it takes to perform the operation by two weeks. This method was used three times for a total savings of \$120,136.
Lyman L. Tremble Gary Hogue	Utilities	\$1,000	Mr. Tremble is a Principal Utility Supervisor, and Mr. Hogue is an Associate Civil Engineer. They suggested that sludge ponds be covered with grass seed to eliminate the process of burying it. This has been done in one location for a savings of \$16,700.
Louis Denov	Transportation	\$ 560	Mr. Denov was an Electronic Technician at the time of his suggestion. His development of a selectable scan capability for Police radios allowed the Police Department to remove 28 radios from supervisors' vehicles. The recovered radios were used in other vehicles that would have required purchase of radios. Total savings of this idea are \$5,606.
William R. Cotton	Utilities	\$ 420	Mr. Cotton is an Equipment Technician II. Mr. Cotton discovered a method of eliminating the condensation in Hersey Compound Meter Registers. Formerly when these registers became fogged, the glass had to be broken to be able to read the meter. This suggestion saves the City \$4175 annually in repair costs.
