<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Daniel Fitterer	Transportation	\$ 380	Mr. Fitterer is an Electronic Technician in the Communications and Electrical Division. One year ago he received a \$200 award for his idea to repair two-way radio battery packs rather than buying new ones. One year's experience shows a total savings of \$5814. This is the remainder of his award.
Louis Denov	Transportation	\$ 290	Mr. Denov was an Electronic Technician at the time of his suggestion. He developed a method of converting Motorola radios to the selectable scan capability without purchasing new circuit boards. Total savings are expected to be \$8,670. This is a partial award pending a final 12-month review.
Stephen J. Linges	Utilities	\$ 190	Mr. Linges is a Utility Worker I. He suggested that dump trucks be fitted with dividers, thus allowing more than one item to be hauled at a time for small jobs. Total savings are expected to be \$3832. This is a partial award pending a final 12-month review.
