WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Jewett H. Shea	Utilities	\$ 85	Mr. Shea is a Utility Worker I. He suggested that water samples be taken twice a week rather than daily. This is expected to save \$1687 annually with no loss in quality control. This is a partial award pending a final 12-month review.
Kathryn L. Christman	Housing and Community Services	\$ 50	Ms. Christman is a Senior Clerk. She devised a form that allows the eligibility clerk to monitor the accuracy of eligibility checks. Savings are estimated at \$1523 annually. This is a partial award pending a final 12-month review.
Danny A. Lewis	Engineering and Development	\$ 35	Danny Lewis is an Intermediate Typist. Danny suggested that a rubber stamp be developed to record the Affirmative Action information necessary for transmittal from the field. This is expected to save \$636 annually. This is a partial award pending a final 12-month review.
Brynhildur Rogers	Fire	\$ 30	Ms. Rogers is an Intermediate Typist. She suggested a better method of updating the Fire Department rolodex system. Although her specific recommendation was not adopted, it was her idea that led to a change being made. Savings are estimated at \$278.
