Linda M. Pfahler Christine Cyrankowski	General Services	\$ 30	Ms. Pfahler and Ms. Cyrankowski are Intermediate Typists. They suggested that a Payroll Clerk checklist be developed. Although their checklist was not adopted, their suggestion was instrumental in the development of the form. Savings are expected to be \$1201 annually. This is a partial award pending a final 12-month review.
Carol E. Dennison	Building Inspection	\$ 30	Ms. Dennison is a Senior Stenographer. She developed the Payroll Clerk checklist that was finally adopted. This is a partial award pending a final 12-month review.
Vincent M. Tombrello	General Services	\$ 25	Mr. Tombrello is a Roofing Installer in the Buildings Division. He suggested that face masks be worn by roofing installers to protect them from splashing tar. This is a significant safety improvement.
Margaret A. Thomas	Risk Management	\$ 25	Ms. Thomas is a Senior Clerk. She developed a new safety training certificate using NCR paper. This saves \$260 annually in the time it takes to copy certificates for personnel folders.
Thomas B. Wells	General Services	\$ 20	Mr. Wells is a Carpenter in the Buildings Division. He suggested that non-skid strips be placed on the bed of the vandalism repair truck. This is a significant safety improvement.
