

RESOLUTION NO. 221607Adopted on AUG 8 1978

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Donald P. Waldman	Fire	\$ 20	Mr. Waldman is an Engineer. He suggested that breast pockets be sown on turn out coats to minimize or eliminate damage done to radios during responses. This is expected to save \$175 annually in radio repairs.
Willie "B" Turner, Jr.	Park and Recreation	\$ 10	Mr. Turner is a Recreation Facility Caretaker. He suggested that Exit lights in Recreation facilities be turned out at night to reduce costs. Although this is not being done for security reasons, the light bulb wattage in Exit lights are being reduced. This is expected to save \$100 annually.
Conward B. Southard	Park and Recreation	\$ 10	Mr. Southard is a Recreation Facility Caretaker. He designed a rubber anchor for the center strap of tennis nets. This saves approximately \$100 annually.
Sylvia Johnson	Utilities	\$ 10	Ms. Johnson is an Intermediate Clerk. She designed a new form to record Utility deposits. This form is much more legible and saves time in researching deposits.
Elizabeth L. Deeg	City Clerk	\$ 10	Ms. Deeg is a Junior Clerk. She suggested that a cart be purchased for the transportation of printed material to and from the Print Shop. This is a significant safety improvement and saves time in the transport of materials.
