William L. Matthews	Utilities	\$ 10	Mr. Matthews is a Waste Water Plant Operator. He suggested that make-up water be used in the scum liquify-ing process rather than fresh water. This saves both water and time.
Deaster Prince	Personnel	\$ 10	Ms. Prince was a Junior Clerk at the time of her suggestion. She suggested that braille elevator buttons be installed in City elevators. This has been done, and it is considered to be a significant improvement.
Lucille S. Alexopoulos	Risk Management	\$ 10	One year ago Ms. Alexopoulos received a \$10 award for her idea to print claims file folders on both sides for re-use. One year's experience has shown that almost \$200 was saved. This is the remainder of her award.
E. Lorraine Payne	Risk Management	\$ 10	One year ago Ms. Payne received a \$10 award for her idea to print five form letters as one. One year's experience has shown that almost \$200 was saved. This is the remainder of her award.
