WHEREAS, certain easements for water purposes were acquired in the Southwest Quarter of Section 1, Township 14 South, Range 4 West, San Bernardino Meridian; and

WHEREAS, the proposed development of the property requires abandonment of these existing easements; and

WHEREAS, the easements no longer serve the purpose for which they were originally acquired; and

WHEREAS, the City has no present or prospective use for said easements and the City Manager has recommended that the City quitclaim its interests therein; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. 764389, quitclaiming to HUGH J. A. and MARGARET CHIVERS, all the City's right, title and interest in those rights of way for water purposes, as more particularly described in said quitclaim deed.
