

RESOLUTION No. 221631


Adopted on AUG 14 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of CHARLES E. SNYDER and JOAN A. SNYDER, husband and wife as joint tenants; JAMES RODNEY YOUNGSON and SYDNEY A. YOUNGSON, husband wife as joint tenants; ELEANOR B. KAHN, a widow; and THE YOUNGSON COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of March 17, 1978, conveying to said City an easement for a right of way for a public street, and incidents thereto, through, over, under, upon, along and across those portions of Lots 63, 64 and 66 of La Jolla Hills and that portion of Lot A of the Resubdivision of La Jolla Hills No. 2, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named HILLSIDE DRIVE.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the San Diego County Recorder.
