BE IT RESOLVED, by the Council of The City of San Diego as follows:

That GRAY, CARY, AMES & FRYE, Attorneys at Law, be employed and appointed as special bond counsel for giving an opinion on any bonds that may be issued to pay for the financing and acquisition of approximately 6 acres of undeveloped canyon land in the Navajo area for the proposed DEL CERRO OPEN SPACE PARK ASSESSMENT DISTRICT (SAN DIEGO PARK DISTRICT NO. 19) under the provisions of the Municipal Improvement Act of 1913 and the San Diego Park District Procedural Ordinance of 1969, pursuant to the terms and conditions set forth in the letter dated May 22, 1978 on file in the office of the City Clerk as Document No. '764426.

BE IT FURTHER RESOLVED, that in the event the proposed proceedings fail to materialize or are abandoned before an assessment has been levied and collected, the City shall not be liable for payment of any of the costs incurred in said employment.
