WHEREAS, Congress is currently revising the Comprehensive Employment and Training Act (CETA); and

WHEREAS, The City of San Diego has operated CETA programs for over four years; and

WHEREAS, recent alterations in that legislation require disclosures of personal information that would be violative of state law; and

WHEREAS, these recent alterations do a disservice to all present and future CETA workers by invading their privacy; and

WHEREAS, the City Council finds that the reasons given for support of this disclosure do not outweigh the harm it would cause; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City of San Diego urges the Congress of the United States to delete the requirement for disclosure of CETA participants' home addresses.
