

That the acceptance by the City Manager of that Grant Deed of A AND F LAND INVESTMENT COMPANY, INC., a California corporation, as to an undivided one-half interest and SURF VIEW DEVELOPMENT CO., a California corporation, as to an undivided one-half interest, executed in favor of The City of San Diego, bearing date of June 8, 1978, conveying to said City fee and easement interests and right-of-way for earth excavation or embankment, slope or slopes and incidents thereto, over, under, along and across all that portion of the Southwest Quarter of the Southwest Quarter of Section 35, Township 18 South, Range 2 West, San Bernardino, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 47 is hereby dedicated as and for a public street and the same is hereby named DAIRY MART ROAD.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution, to the Property Director for further handling.
