VACATION OF A PORTION OF MARKET STREET

WHEREAS, it is proposed that a portion of Market Street be vacated; and

WHEREAS, there is no present or prospective use for the portion of the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated in that The City has initiated this action to facilitate the sale of Lot 6 in its Market Street Industrial Park; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that a portion of Market Street, as more particularly referred to in Resolution of Intention No.

221345, is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that a portion of Market Street, as more particularly shown on Drawing No. 14238-B on file in the office of the City Clerk as Document No. 763986,



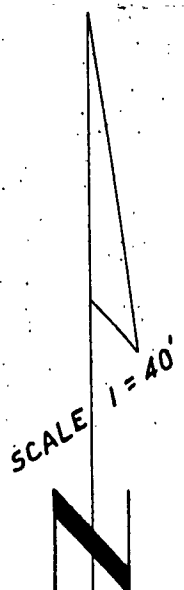
