

RESOLUTION NO. 221670Adopted on AUG 21 1978

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Kathleen D. Martinez	City Clerk	\$60	Ms. Martinez was an Intermediate Typist at the time of her suggestion. She suggested several ways to simplify the procedures of the Numbering Desk. This is expected to save \$576 annually.
Ruth Schimerling	City Council	\$60	Ms. Schimerling is an Administrative Trainee in the 8th Council District. She suggested that documents sent to the Council be pre-punched for placing in three ring binders. This is now done centrally in the Print Shop. Savings are estimated at \$601.
Stephen J. Linges Carl Jackson	Utilities	\$50	Mr. Linges is a Utility Worker I and Mr. Jackson is a Laborer in the Utilities Systems Division. They suggested that wood blocks be used to support "hi-line" piping during installation. This is considered to be a significant safety improvement.
James R. Cook	Park and Recreation	\$50	Mr. Cook is an Equipment Operator I in the Parks Division. He suggested that a foot throttle be installed on Ransomes 7-gang mowers used in the Park Division. This is considered to be a significant safety improvement.
Patricia E. Tucker	City Clerk	\$35	Ms. Tucker was a Junior Stenographer at the time of her suggestion. She suggested that a register be placed at the speaker's podium in Council Chambers. This saves \$344 annually in the time it takes to verify speakers' names and addresses.
