Linda H. Wong	City Clerk	\$10	Ms. Wong is an Intermediate Clerk. She developed a form letter for negative responses to address inquiries. The use of this form letter saves \$100 annually over the cost of typing each response.
Linda H. Wong	City Clerk	\$10	Ms. Wong is an Intermediate Clerk. She devised a simpler method of providing a route slip for City Council Dockets. Savings are estimated at \$100 annually.
Val Kisak	Park and Recreation	\$10	Mr. Kisak is a Recreation Facility Caretaker in the Recreation Division. He suggested that water flow restrictors be installed on free flowing spigots. This is expected to save \$100 annually in the cost of water.
Val Kisak	Park and Recreation	\$10	Mr. Kisak is a Recreation Facility Caretaker in the Recreation Division. He suggested that wind screens be repaired as soon as they become torn or ripped. This saves \$100 annually in repair costs
Kevin V. Munnelly	Financial Management	\$10	Mr. Munnelly is the Endowment Officer. He suggested that a space for ATSS calls be placed on Form BD-117, Long Distance Call Record. This is expected to serve as a valuable reminder that callers should use ATSS whenever possible.
