
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Change Order No. 7, dated August 15, 1978, heretofore filed with the City Clerk of said City as Document No. 764287, issued in connection with the contract between The City of San Diego and M. Arrieta & Son, Inc., for POINT LOMA WASTEWATER TREATMENT PLANT SLUDGE LINE REPLACEMENT, said contract having been filed in the office of the City Clerk as Document No. 758684, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$278,034.00 and granting a 60-working day extension of time, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$173,034.00 within Sewer Revenue Fund 506 from the Unallocated Reserve (69.97) to CIP City Force and Contract (64.92) CIP 46-037.

BE IT FURTHER RESOLVED, that the expenditure of \$173,034.00 from Sewer Revenue Fund 506 is hereby authorized, solely and exclusively, for this purpose and related costs.
