WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Lester E. Jennings	Utilities	\$410	Mr. Jennings is a Storekeeper I in the Utilities Systems Division. He suggested that a soil pipe cutter be used to cut asbestos pipe. Not only does this save \$4,089 a year in the cost of materials, but it is also a much safer method of operation.
Karen L. Woods	City Attorney	\$360	Ms. Woods is a Principal Clerk in the Criminal Division. She suggested that complaint reports be printed on different colored paper for the Setting and Motion and Presiding Departments. This is expected to save \$3,614 annually in search and filing time.
Dianna J. Valstad	City Attorney	\$100	Ms. Valstad is an Intermediate Typist in the Criminal Division. She suggested that different colored top sheets be xeroxed rather than having them retyped. This is expected to save \$1,005 annually.
David A. Pruitt	Fire	\$100	Mr. Pruitt is a Fire Equipment Repair Supervisor. He suggested that wooden blocks be used to brake Fire trucks when returning from responses. This is expected to save \$2,856 annually in the damage caused to brake drums by setting the spring brake when drums are at maximum expansion. This is a partial award pending a final 12-month review.
