Thomas W. Hall	Police	\$1,000	Mr. Hall is a Police Sergeant. He suggested that a back x-ray program be included as part of the pre-employment physical for applicable job classifications. Savings are estimated at a minimum of \$140,000 annually in City costs of disability retirement.
Cynthia E. Hill Christine M. Loss Calvin L. Krosch Gloria M. Leary Margaret A. Watson	Purchasing Police Personnel	\$1,000	All of these suggesters suggested the elimination of periodic physical examinations for City employees. The adoption of this idea is expected to result in a savings to the City of \$106,363 in contract and personnel costs.
Aldo Chiappone	Water Utilities	\$ 500	One year ago Mr. Chiappone suggested that the Nimitz Boulevard by-pass be modified to eliminate the existing natural sand and rag trap. One year's experience has shown a total savings of \$11,440 as a result of his idea. This is the remainder of his award.
