BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council find that that certain map surveyed by E. F. COOK, a Registered Civil Engineer, entitled "RANCHO BERNARDO RACQUET CLUB Being a subdivision of Parcels 1 and 2 of Parcel Map No. 7064, in the City of San Diego, County of San Diego, State of California, according to Map thereof filed in the office of the County Recorder of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Bernardo Terrace for public purposes; and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of water facilities as granted and shown on said map and subject to the conditions set forth thereon.


