
Adopted on AUG 28 1978 (REV.)

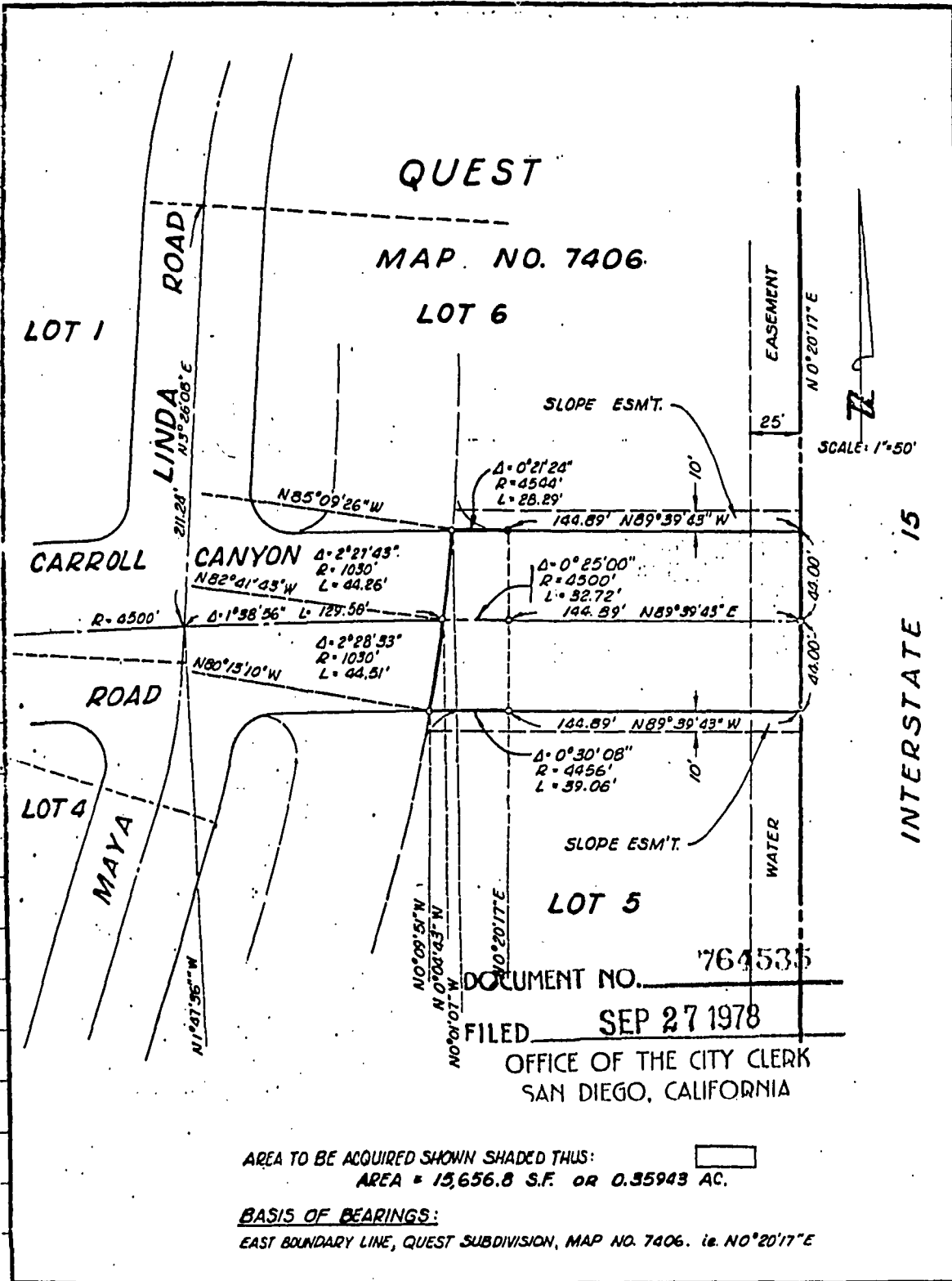
