

RESOLUTION No. 221691 (R. 79-303)


Adopted on AUG 28 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of M. B. CONSTRUCTION AND DEVELOPMENT COMPANY, a California Corporation, executed in favor of The City of San Diego, bearing date of July 13, 1978, conveying to said City the permanent easement and right-of-way for a public alley for a portion of Pueblo Lot 1234, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public street and alley purposes.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
