

WHEREAS, On February 16, 1977, the City Council authorized the acquisition of approximately 125 acres in Crest Canyon under a joint Del Mar - San Diego Project; and

WHEREAS, all of the properties have been acquired or are in condemnation; and

WHEREAS, early in the acquisition process, one of the parcels in Del Mar consisting of 3.5 acres was acquired by The City of San Diego to be reimbursed when funds became available; and

WHEREAS, Del Mar has since reimbursed The City of San Diego for the acquisition and should therefore obtain title to the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which is on file in the office of the City Clerk as Document No. 764499, granting to THE CITY OF DEL MAR the City's right, title and interest in Lots 684, 759 and 760 of Arden Heights No. 6, as more particularly described in said grant deed.
