WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Danny L. Lenz	General Services	\$500	Mr. Lenz is a Painter in the Buildings Division. He suggested that gymnasium floors receive a coat of floor finish quarterly. The adoption of this suggestion doubles the life of a gym floor before a major refinishing job must be done. Estimated savings are \$16,940. This is a partial award pending a final 12-month review.
Aldo Chiappone	Water Utilities	\$475	Mr. Chiappone is a Plant Maintenance Mechanic in the Water Quality Division. He suggested that transfer pumps be converted to direct drive motors. This prevents motor breakdowns and saves \$4,750 a year.
John H. Vaughn	Fire	\$200	Mr. Vaughn is a Fire Captain. He suggested that wall maps in Fire Stations be covered with a protective material. This is expected to double the life of wall maps. Estimated savings are \$5,130. This is a partial award pending a final 12-month review.
Robert S. Zarkos	Police	\$145	Mr. Zarkos was a Police Officer at the time of his suggestion. He suggested that battery testers be used to test batteries and retain those still useful. This is expected to save \$2,920 annually. This is a partial award pending a final 12-month review.
