That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Phillip J. Love	General Services	\$ 80	Mr. Love is a Carpenter Supervisor in the Buildings Division. He suggested that rim fire exit bolts be used on single exit doors. This is expected to save \$1,788 annually in maintenance calls. This is a partial award pending a final 12-month review.
John E. Mills	Engineering & Development	\$ 60	Mr. Mills is a Project Officer I in the Field Division. He suggested a simplified method of transmitting the weekly "Statement of Working Days." This is expected to save \$1,248 annually. This is a partial award pending a final 12-month review.
Charles R. Johnson	Library	\$ 50	Mr. Johnson is a Senior Typist. He suggested that camera baseboards be redesigned to include the basic instructions concerning overdue books. This is expected to save \$1,251 annually. This is a partial award pending a final 12-month review.
Nina L. Ladd	Police	\$ 35	Ms. Ladd is a Senior Clerk. She suggested that a \$5 service charge be levied for processing subpoenas involving civil action. This results in \$370 annually of additional revenue.
