Faye L. Walsh	Personnel	\$ 10	Ms. Walsh is an Intermediate Typist in the clerical pool. She suggested that a memorandum be issued to all departments urging the use of third class mail for certain bulk mailings. This is being done. Savings are difficult to calculate.
