<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Gloria L. Gordon	Police	\$ 15	Ms. Gordon is an Intermediate Typist She suggested that old bicycle licenses be removed from auctioned bicycles prior to auctioning. This will make sure that bicycle buyers know that licensing is required. Savings are expected to be \$150.
Earl M. Shepard	Fire	\$ 15	Mr. Shepard is a Fire Fighter. He suggested a revision to the form currently used to log bicycle registrations. This idea is expected to improve record keeping and provide additional information.
Robert H. Marlow	Fire	\$ 15	Mr. Marlow is an Engineer. He suggested that Fire apparatus brake testing be conducted on week days. This eliminates any overtime charged as a result of brake problems. Savings is \$150 annually.
George E. Hubbard	General Services	\$ 10	Mr. Hubbard works in the Streets Division. He suggested that trash bags be distributed to Life Guards for dead seal disposal. This will alleviate any public health and public relations problems caused by disposal.
