<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Nina L. Ladd	Police	\$ 55	Ms. Ladd is a Senior Clerk. She suggested that the filing of PD-129 in traffic collision file jackets be eliminated. It was decided that these route slips were not required as a permanent part of the file. This saves \$535 annually.
Susan E. Roos	Police	\$ 55	Ms. Roos is an Intermediate Stenographer. She suggested that Business License renewals be sent through the mail prior to the change of mail rates from \$.13 to \$.15. This resulted in a savings of \$575.
Sylvia Johnson	Water Utilities	\$ 15	Ms. Johnson is an Intermediate Clerk. She suggested that the Utilities white door hanger include a Spanish translation on the reverse side. This is expected to improve public relations.
Sylvia Johnson Olivia Sardinha	Water Utilities	\$ 15	Both Ms. Johnson and Ms. Sardinha are Intermediate Clerks. They suggested that post cards for bill returns be printed in Spanish as well as English. This is expected to improve public relations.
Russell I. Skillman	General Services	\$ 15	Mr. Skillman is a Senior Clerk in the Buildings Division. He suggested that the building directory in the City Operations Building be changed to make it more obvious and useful to citizens. This is expected to improve public relations.
