RESOLUTION NO. 221730

(REVISED)

WHEREAS, by Resolution No. 217594 adopted on February 1, 1977, the City Council granted an individual owner/operator Certificate of Public Convenience and Necessity to operate a taxicab to one Steven F. Ferguson; and

WHEREAS, Steven F. Ferguson has been in violation of San Diego Municipal Code Sections 72.0104 and 72.0107 and Council Policies 500-2 and 500-5 in that his past record has been shown to be unsatisfactory; as more fully evidenced by a report from Mr. Martin Breslauer, Assistant to the City Manager, acting as a hearing officer in connection with this matter, a copy of which report is on file in the office of the City Clerk as Document No. 764608.

WHEREAS, pursuant to San Diego Municipal Code Section 72.0101(k) Steven F. Ferguson's actions, as indicated by said report and the testimony before this City Council, provides reasonable justification for revoking his certificate in the absence of any extenuating circumstances; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That extenuating circumstances having been found, said certificate is not revoked at this time.

BE IT FURTHER RESOLVED, that it is the intent of the Council to revoke said certificate if any violation of the law by Mr. Ferguson is reported by the Police Department to the City Council. This includes any moving violation, any failure to
