BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, First Amendment to Agreements with COMMUNITY HOSPITAL OF SAN DIEGO and CABRILLO MEDICAL CENTER/DOCTOR'S HOSPITAL for the purpose of extending contract expiration dates, increasing applicable fees, and incorporating provisions for expanded services to rape victims, under the terms and conditions set forth in said First Amendment to Agreements on file in the office of the City Clerk as Document Nos. 764558 and 764559.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$20,000 from the Housing and Community Services Revenue Sharing Social Service Program to Police Department Program/Element 15.03, Object Account 32.99, to be used solely and exclusively for the purpose of providing funds for the above described services.
