That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with the COMPREHENSIVE PLANNING ORGANIZATION (CPO) for the purpose of increasing the amount of CETA Title VI funds allocated to CPO from \$9,000 to \$10,300, said First Amendment to Agreement is on file in the office of the City Clerk as Document No. 764560.

BE IT FURTHER RESOLVED, that the expenditure of \$1,300 is hereby authorized out of CETA Title VI Fund 28662 of The City of San Diego, solely and exclusively, for the above purpose.
