RESOLUTION CONCURRING IN THE FIRST AMENDMENT  
TO THE SAN DIEGO REGIONAL SOLID WASTE PLAN.

WHEREAS, Section 17939 of the California Administrative Code precludes the implementation of new or expanded solid waste facilities within counties having approved county solid waste management plans without a finding by the State Solid Waste Management Board that such facilities are in conformance with approved plans; and

WHEREAS, the County of San Diego has an approved county solid waste management plan; and

WHEREAS, the County of San Diego considers it necessary to provide for replacement or additional industrial liquid waste handling facilities to accommodate the region's waste loadings; and

WHEREAS, the State Solid Waste Management Board is unable to make a finding of conformance with the San Diego Regional Solid Waste Management Plan for replacement or addition of industrial liquid waste facilities because such facilities are not specifically identified within this county's Plan, and, therefore, requires that the Plan be amended before such a finding of conformance can be made; and

WHEREAS, any amendment to the County Solid Waste Management Plan is subject to the approval of the majority of the cities within the County representing a majority of the population of the incorporated area of the County; NOW, THEREFORE,
