


RESOLUTION NO. 221767 (R. 79-186)

Adopted on SEP 5 1978

BE IT RESOLVED, by the Council of the City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to submit, for and on behalf of said City, a Grant Application for the Fifth Year Community Development Block Grant Program in the amount of \$11,000,000, including appropriate certifications and assurances, to the United States Department of Housing and Urban Development (HUD), under Title I of the Housing and Community Development Act of 1974, the form of Grant Application is on file in the office of the City Clerk as document no. 764557; and upon approval by HUD, the City Manager is hereby authorized to execute said Grant Agreement and implement the projects contained therein. If it becomes necessary, as directed by HUD, the City Manager is hereby authorized to transcribe the contents of the Application and supportive certifications and assurances onto applicable new forms and resubmit the Application to HUD.
