BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of 66TH STREET AND LEGHORN STREET, AND SKYLINE DRIVE AND CIELO STREET, in the City of San Diego, by grading, paving, installation of curbs, sidewalks, water mains and any right-of-way as required, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
