

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, UTILITIES AGREEMENT NO. 23907 with the STATE DEPARTMENT OF TRANSPORTATION for INSTALLATION OF WATER FACILITIES ON INTERSTATE ROUTE 15 IN DUENDA ROAD OVERCROSSING, said agreement is on file in the office of the City Clerk as Document No. 764680.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces all necessary work in conjunction with the above referenced project of performing operational checks and to make connections where required at a cost not to exceed \$1,500, pursuant to the recommendation of the City Manager and the submission of estimates by him that said work can be done more economically by City forces than if let by contract.
