


RESOLUTION No. 221810 (R-79-419)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the sole bid of \$374,524 by SCHEIDEL CORPORATION, a corporation for IMPROVEMENT OF FASHION VALLEY ROAD AT THE SAN DIEGO RIVER CROSSING (STORM DAMAGE REPAIR) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 764034.
2. That the expenditure of \$24,855 is hereby authorized out of the Capital Outlay Fund Reserve, that the expenditure of \$312,319 is hereby authorized out of the Gas Tax Fund Reserve, and that \$121,000 is hereby authorized out of the Water Revenue Fund (502) of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
