BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the offer of KUHLMAN EQUIPMENT COMPANY is hereby accepted and the City Manager is hereby authorized to execute a contract for the rental of a LANDFILL COMPACTOR (Tana S40) for a three (3) months' period with an option to renew rental for an additional three (3) months' period for a rental charge of \$5,000 per month terms net 30 days plus sales tax with an option to purchase at the end of the first three (3) months' period for \$158,000.00, terms net 30 days plus sales tax with an option to purchase at the end of the second three (3) months' period for a cost of \$146,000.00, terms net 30 days plus sales tax plus transportation cost of \$12,000.
