WHEREAS, a certain easement and right of way for sewer purposes was acquired in Lot 67 of Mission Hills, according to Map thereof No. 1115, filed in the office of the County Recorder of San Diego County, January 20, 1908; and

WHEREAS, the development of the property requires abandonment of a portion of that existing easement; and

WHEREAS, the portion of the easement to be abandoned has never been used for the purpose for which it was acquired; and

WHEREAS, the City has no present or prospective use for said easement and the City Manager has recommended that the City quitclaim its interests therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. 764610, quitclaiming to ANTHONY A. O'HARA and KATHLEEN H. O'HARA, husband and wife, as community property, all the City's right, title and interest in a portion of that easement and right of way for sewer purposes, as more particularly described in said quitclaim deed.
