

RESOLUTION No. 221821 (R. 79-375)


Adopted on SEP 18 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of KENNETH E. PETTIT and PATTI A. PETTIT, executed in favor of The City of San Diego, bearing date of June 12, 1978, conveying to said City a permanent easement and right of way for public street and incidents thereto over, under, upon, along and across all that portion of Lot 56, Empire Addition to Encanto Heights, according to Map thereof No. 1254, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named RADIO DRIVE.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution attested by him under seal, to be recorded in the office of the San Diego County Recorder.
