That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Bement - Dainwood - Sturgeon, a California corporation, to provide professional engineering services in connection with the improvement of Adobe Falls Road from the north line of College Canyon Subdivision to Waring Road, in the City of San Diego, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. 764527.

BE IT FURTHER RESOLVED, that the expenditure of \$11,000 and \$12,000 is hereby authorized out of Capital Outlay Fund 245 and Gas Tax Fund 220 respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for the above referenced services.
